## Private School Tuition Contributions

The organization you donated to must be a nongovernmental Arizona private school tuition organization that provides scholarships or grants to qualified schools. You **cannot** take a credit for contributions for the direct benefit of your dependent. The tuition organization gives you a receipt showing the qualifying fees paid and all the information necessary to claim the credit.

Keep these receipts handy as you complete this topic. You might want to attach a copy of the receipts to your Arizona tax return to substantiate your claim for credit. [Learn More](#)

## Maximum Credit

Your maximum available credit for contributions to private school tuition organizations (Form 323) made during **2019 is limited to \$1,138**

You have an additional credit of up to **\$1,131** Form 348 if your donation exceeds the limit for Form 323.

We've calculated an additional available credit **\$1,131**. There is nothing more you need to do.

These credits will only reduce your tax to zero. If you don't need these credit **2019** they will carryover to next year for up to five years from when you made your original donation.

## Deduction Entered on Federal Return?

### Contributions to School Tuition Organizations (Forms 323 and 348)

If you entered a **deduction** on your federal return for this **\$2,269** allowed credits, your Arizona itemized deductions for charitable contributions must be reduced by the amount of the credit claimed.

If you did not enter a deduction for this contribution on your federal return, or the amount does not equal the deduction you did take (up to the amount of the credit), change the amount below. If the amount should be larger, adjust the contributions amount on federal Schedule A.

Amount **\$1,138** Form 323 credit claimed on your federal return.

Amount **\$1,131** Form 348 credit claimed on your federal return.
